Question -

Questions – When in the hazard mitigation plan update due/expected to be completed?

## Answers -

Good afternoon,

The Hazard Mitigation Plan has expired. The updated needs to be completed as soon as possible. The Period of Performance for the Grant end February 2026. These means the update completed, approved by DHSEM, approved by FEMA and adopted by all jurisdictions. Thank you.

What is the anticipated timeline for this contract? The Appendix C Draft Contract lists "automatically renew on February 1st each calendar year for two (2) additional one-year terms" but also lists February 1, 2026 as expiration date.
